


Visits to Municipal Facilities



On July 29, 2012, visits to municipal facilities were organized in order to help the representatives become more familiar with the city of Kawasaki, in the hope that they will be able to use this knowledge in future discussions in the Assembly. A total of fifteen representatives participated in this event, receiving explanations and exchanging opinions while visiting a total of five municipal facilities.

Time-consuming topics: community development, support for employment, assessment of and follow-up on proposals, and transmission of information (Representative Assembly's homepage, hearing opinions of foreign nationals using the website, disaster information, new immigration procedures, and other topics.)

A wide variety of topics are being discussed this time, including new topics such as community development. The representatives actively participated in the discussions, bringing their opinions, based on unique and rich experiences, to bear on these issues. We hope to continue further discussions while respecting each others' opinions.

Discussion Topics

Support for guardians (such as providing information for guardians), bullying problems, welfare services for the elderly, education at home, multicultural exchange, support services for raising infants (such as nursery schools and facilities for children), medical care, and native language education.

The Representative Assembly introduced in a French Book

The Representative Assembly's photo appeared on the cover of a book entitled 'Highly skilled Chinese migrants in Japan', published by the French company Les Indes savants in February of 2012. The book introduced the Kawasaki City Representative Assembly for Foreign Residents as the most active and successful organization in gathering the opinions of foreign nationals residing in Japan. In June of 2012, Chairperson WANG held a discussion with the author, Dr.

Hélène LE BAIL. Dr. LE BAIL pointed out that the Chinese residents are more socially active and that better multilingual services are offered in Japan in comparison to France. She also commented that civic activities and schools may be utilized in order to further our understanding of the needs of the local foreign residents. Chairperson WANG, after learning that several foreign languages can be studied in public elementary schools in France, mentioned that he would like more opportunities offered at public schools in Japan as well for studying foreign languages (native languages.)

Introduction of a new residency management system - FAQ

A new residency management system has been introduced, effective July 9, 2012. Important points about the new system selected by the Editorial Committee are explained below.

Q. Is it necessary to exchange the current alien registration certificate for the new resident card immediately?

A. It is not necessary to obtain the new resident card immediately. As of July 9, 2012, alien registration certificates will be deemed equivalent to the resident card for a period of time, for those eligible under the new residency system. For those with a status other than permanent resident, a resident card will be issued when certain application processes, such as renewal of the validity of the period of stay, are undertaken after July 9. Permanent residents will be required to file an application to receive a resident card within three years from July 9, 2012 (those under the age of 16 must file an application within 3 years or prior to their 16th birthday, whichever comes earlier.)

Q. Will I receive a renewal notification before the expiration date of my period of stay and/or my resident card?

A. You will not receive a notification. As long as the status of residence is renewed before the final date of the period of stay, the validity date of the resident card will not expire for those with mid-term or long-term resident status (excluding permanent residents and foreign nationals under the age of 16.) Please do not forget the final date of your period of stay.

Q. Is it necessary to submit the photo that will be shown on the resident card?

A. You do not need to submit a photo for a resident card issued at the airport. When filing an application for a resident card or the renewal of your status of residence, you will need to submit a photo taken within three months prior to submission of your application. Photographs will not be shown on resident cards with the period of stay expiring before the foreign national's 16th birthday.

[Attention!] New grounds have been established for the revocation of residency status, deportation, and penalties under the new residency management system. For more information, please contact the nearest regional immigration bureau.
