

On Monday, April 15, Ping WANG, Chairperson of the Ninth Representative Assembly, and David CHART, Life and Society Section Leader submitted the FY2012 Annual Report to Mayor ABE. Chairperson Ping WANG explained the discussion topics of the Representative Assembly in FY2012, the opinions expressed, and details of activities in the Open Forum to the Mayor based on the annual report. Mayor Abe said, "I am looking forward to seeing good proposals emerge through further deepening the discussions in the remaining year" in response.

On Wednesday, May 22, Chairperson Ping WANG and Vice-Chairperson Gajender SHARMA were invited to attend the City Assembly Citizens' Committee as witnesses and made a statement based upon the annual report about the Representative Assembly's FY2012 activities. ◆♦ The Kawasaki City Representative Assembly for Foreign Residents

Now Seeking Members for the Tenth Representative Assembly

The Representative Assembly for Foreign Residents was established in 1996 by ordinance to promote development of better local communities through mutual understanding among the local residents. Assembly members will investigate and hold discussions on topics they have chosen from among the thoughts, concerns or problems currently shared by foreign residents, and submit proposals to the Mayor. This is your chance to ensure that your voice is heard by the city administration.

- Term: Two years from April 1, 2014 through March 31, 2016
- Assembly Activities: Meetings are held eight to nine times a year, generally on Sunday afternoons.
 - * Meetings are conducted in Japanese.
 - *Compensation as a special public servant will be provided for participation in these meetings.
- Qualifications:
 - ①Do not possess Japanese citizenship.
 - ②Be 18 years old or above as of April 1, 2014.
 - 3 Have been continuously registered as a resident of Kawasaki for at least one year as of April 1, 2014.
- To Apply: Submit your application by mail, postmarked by Friday, December 13, 2013
 - * Application forms will be available starting in October at ward offices, civic halls, libraries, and the Kawasaki International Center.

 The Representative Assembly is an excellent place for discussion where people of various nationalities come together, and you can engage in discussions in order to help make the city a better place to live for foreign residents in Kawasaki.

 only for foreign residents, but also to build proposals for community development that would also benefit

- Being a representative, I was able to participate in various events held within local communities, and it
 gave me opportunities for contact with many Japanese residents. I would like to expand the range of
 contact even further through this Representative Assembly.
- I decided to join the Assembly because I wanted to help those foreign residents who are not so fluent in Japanese. I would like to help make the city of Kawasaki a more comfortable environment to live in, through cooperating with the other representatives.
- Why don't you take part in the activities of the Representative Assembly in order to help foreign residents live a better and more comfortable life in Japan, and to promote mutual understanding and to further deepen the communication between Japanese and foreign residents?

Meeting Reports

■ Welfare and Education Section

Within the Welfare and Education Section, discussions were carried out mainly focusing on the topics of "native language education" and "multicultural exchange." Staff from the Board of Education were to invited to explain the details of certain efforts such as encouraging citizens to undertake projects and offer services in an independent way. We also conducted some field research. During the discussions on "multicultural exchange", representatives suggested encouraging the Representative Assembly to become more engaged by visiting schools and giving on-site lectures, as such an effort itself may be a good way to promote awareness of the Representative Assembly.

Additional topics such as "support services for raising infants" and "welfare services for the elderly" were also discussed. On the topic of "support services for raising infants," the following contents were brought up for discussion: (1) the system in Japan for raising infants; and (2) admission and the problem of waiting lists for nursery schools. On the other hand, discussions over "welfare services for elderly" centered on reviewing the contents of the proposals submitted in the past and their progress status.

We will continue to work towards building proposals by exchanging information and sharing our experiences within the Welfare and Education Section, to help develop the city of Kawasaki into a better place to live for foreign residents.

■ Life and Society Section

Discussions on the main topics of the Life and Society Section were completed in the previous meeting. Although we held discussions on the topic of "attracting enterprise" over several sessions, in conclusion we reached a consensus that we cannot build a concrete proposal for this issue as there are currently no representatives with expert knowledge in this field. We also reconfirmed our awareness that the big issue of "transmission of information" is indeed a very difficult problem. Certain unresolved issues still remain, particularly on the methods for transmitting information to foreign residents who are rather passive in seeking out information, even though Kawasaki city does have a relatively sound system established for providing information to those foreign residents who are actively seeking out information.

Additionally, discussions were held over the "assessment of and follow-up on proposals." We are considering the possibility of introducing assessment by third parties, as the current system relies on just the self-assessment of results conducted by the designated department by the city. Finally, as the last major topic of discussion, we considered the topic of "support for employment". As with the other issues, information is made readily available through the city or public agencies such as Hello Work, but we have heard numerous stories from foreign residents that they were not offered jobs because they were not Japanese. The city does not have the power to influence and change the mindsets of employers, but we discussed the possibility of establishing systems to help resolve such issues. We will focus on selecting topics and deciding on wording for the proposals during the remaining meetings.

 - If the plastic packaging/container cannot be cleaned:
 - → Dispose of the item as "Regular Trash"

 - *"Regular Trash" pickup days are being reduced from three times to twice a week.
