Empty Bottles

Used Batteries

Once a week

Recyclable Resources

- Take them to the recyclable resource collection site by 8:00 a.m. on the collection day.
- ※ If you have specific rules, such as for the residence association of your condominium, priority should be given to these rules.
- Do not put cigarette butts or garbage in empty cans, PET bottles, or empty bottles; it hinders the recycling process.

※Classification of "caps and labels"
If labels and caps cannot be easily removed, they may be left attached.

○Metallic caps empty cans

○Plastic caps and labels plastic containers and packaging

Empty Cans and PET Bottles

- Place together in transparent/semi-transparent bags before disposal.

Empty Cans



In order to avoid fire incidents, please empty the spray cans and butane gas cassette cartridges using caps which are specialized to empty safely. For emptying, please use outdoor where no fire can occur and dispose them together with empty cans and PET bottles.

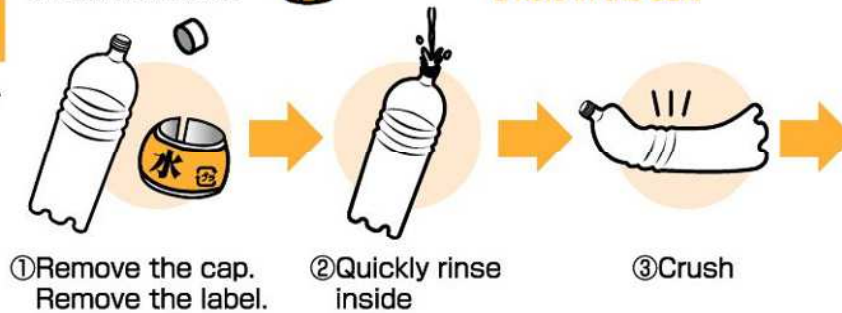
※ It is not necessary to pierce a hole in the can.

PET Bottles

Distinctive label for PET Bottles



Only those PET bottles with this label shall be collected.



- ① Remove the cap. Remove the label.
- ② Quickly rinse inside
- ③ Crush
- ④ Place together in transparent / semitransparent bags

※Applicable PET bottles are beverage, sake, "mirin" cooking wine and soy sauce containers with the indicating "PET" mark.

Empty Bottles

- Remove the cap, quickly rinse, and place the bottle in the Empty Bottles container.

※Empty bottles for culinary products, such as those for beverages, seasonings, and cooking oils, etc.

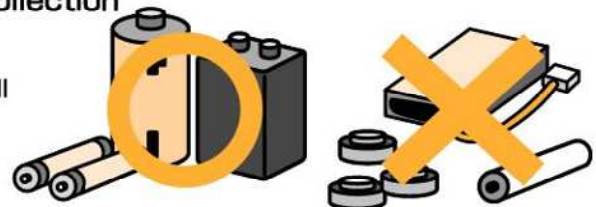
※Dispose of returnable bottles such as "issho-bin" sake bottles and beer bottles with local group recyclable resource collections or return them to a shop or store of purchase.



Used Batteries

- Put them in transparent plastic bags and place them at the recyclable resources collection site by 8:00a.m.

※The city collects only layered- and cylinder-type dry cell batteries, and coin-type lithium cell (CR and BR type). (Please refer to page 36 for disposal of button and rechargeable batteries.)

Mixed paper

Once a week

Recyclable Resources

- All types of paper except for "items collected by local recyclable resource collection groups" and "dirty paper and paper with strong smell"
- Take them to the recyclable resource collection site by 8:00 a.m. on the collection day.



Paper items with this mark (confectionery boxes, etc.) as well as flyers, pamphlets, wrapping paper, (windowed) envelopes, postcards, photographs, notebooks, notepads, shredded paper, etc.

For those who are concerned about the protection of personal information on paper, delete such information before disposal.

Types of paper that should not be disposed of as mixed paper



Dirty paper and paper with strong smell.

Please dispose of them as ordinary trash.



Newspapers, magazines, cardboards, milk cartons, etc.

Please use local recyclable resource collection groups or take them to the place of purchase.

Disposal procedures

※Collection of mixed paper is available even on rainy days.

Point

Mixed paper may be put in a paper food box or an empty tissue box.



Do not put mixed paper in a plastic bag (shopping bag) or a cardboard box.



Put mixed paper in a paper bag.



Wrap mixed paper with wrapping paper.



Tie mixed paper with string.

Plastic Containers and Packaging

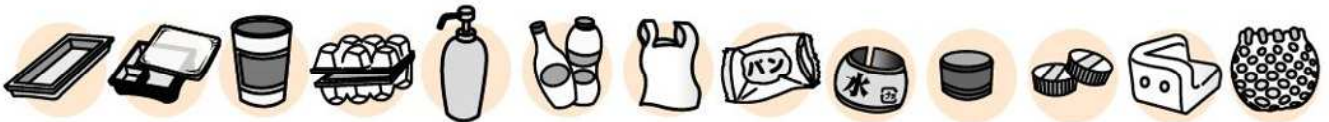

Food packaging trays, cup noodle containers, shampoo bottles, plastic bags for snacks, and other plastic containers and packaging

Those that cannot be disposed of as plastic containers and packaging



Plastic products

※Dispose of them as ordinary trash (or oversized trash).



PET bottles

Dispose of them as "empty PET bottles".



Those with tough stains or contents in them

Dispose of them as ordinary trash.

Disposal procedures

Point

The volume of trash can be reduced by piling or cutting them.

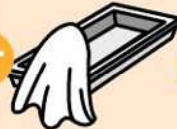


Do not put small plastic bags (e.g. shopping bags) filled with plastic containers and packaging in a larger bag.



Reuse water used for dishwashing, etc., to rinse them.

Quickly rinse.



Wipe the dirt.



Put them in a transparent or semi-transparent bag.



No Garbage collection on Sundays and New Year's Hollidays(Januari 1st to 3rd.)

Ordinary Garbage

Twice a week

Garbage other than "Recyclable Resources (p. 6 & 7)", "Small Metal Articles (p. 9)", and "Oversized garbage (p. 9)"

● Dispose of Garbage in plastic containers with lids or transparent/semitransparent bags by 8:00 a.m. on the collection day.

※ Do not dispose of trash after trash collection has been completed or at night; it is an annoyance to those who live near the collection site.

● Points before disposing of Garbage

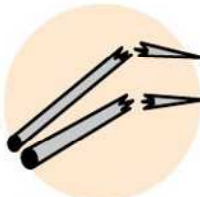


Kitchen Garbage
Please drain completely and solidify any used cooking oil.

Less than 50 cm



Tree Branches, Twigs and Boards
Cut into pieces with measurements of less than 50 cm in length and 10cm in thickness, bundle with string, and dispose of about three bundles per collection.



Skewers for Yakitori
Bend the tips to make them safer before disposal. (Wrap the tips with paper)



Used Cooking Oil
Please try to use up all the oils. Either absorb in cloth or use a solidifying agent before disposing with the ordinary trash.

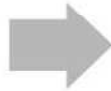
Breakables

Should be wrapped with thick paper with the indication "フレモノ/キケン (Broken/fragile articles, handle with care)" and taken out on the day of collection for ordinary garbage. *Do not put broken/fragile articles (ordinary garbage) in an "Empty bottle collection bucket".



Cups, Rice bowls, Glass, Ceramic items, etc.



Fluorescent Lights



Wrap a fluorescent light (including a broken one) with thick paper or put it in the same box in which it was purchased with the indication " けいこうかん ", and dispose of it.

Caution! When disposing of a fluorescent light, do not put it in a bag containing kitchen garbage and others.

For the collection of paper (newspapers, magazines, etc.), clothes, etc., use local recyclable resource collection by citizen groups.

Item	Disposal procedure	Collection site/Collection day
Paper  ※Some citizen groups may collect paper other than those listed on the right.	Newspapers/Flyers	Fold them into 4 and tie them with string.
	Magazines/Books	Tie those of the same size with string.
	Cardboards	Fold, flatten, and tie them with string.
	Milk cartons	Open, wash, dry, and tie them with string
 Clothes	Old clothes, etc.	Wash, dry, and put them in a transparent or semi-transparent bag.
Returnable bottles	"Issho-bin" sake bottles, beer bottles, juice bottles, etc.	Lightly wash the inside of the bottles.
		Take them to the site on the day specified by each local citizen group. For details of the collection site and the collection day, contact a Waste Collection Office .

※The table above shows examples of typical procedures for the collection of recyclable resources by citizen groups. Note that items and disposal procedures vary depending on the citizen group.

※We also encourage taking milk cartons to supermarkets with collection bins, ward offices (excluding the Kawasaki Ward office), and ward branches.

Small Metal Articles

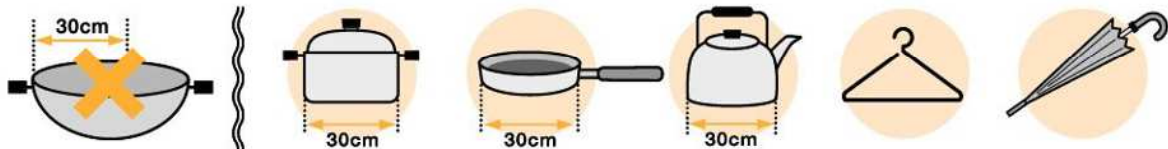
Twice a month

Metal products measuring less than 30cm (those that are entirely or partially made of metal), umbrellas, and wire hangers

- Take them to the "recyclable resource collection site" by **8:00 a.m.**; **Do not put them in a bag** (for those that are easily scattered, tie them with string or tape).

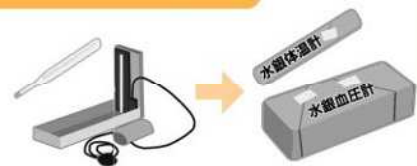
Examples of Small Metal Articles

- Ladles ● Spoons ● Pots ● Frying pans ● Kettles
- Irons ● Electric shavers ● Toasters ● Blow Dryers ● Radios



Mercury Clinical Thermometer, Mercury Manometer, and Mercury Thermometer

Wrap a mercury clinical thermometer, mercury manometer, or mercury thermometer with thick paper with the indication "すいぎんたいおんけい(Mercury Clinical Thermometer)", "すいぎんけつあつけい(Mercury Manometer)", or "すいぎんおんどけい(Mercury Thermometer)", and dispose of it. If its length is 30 cm or longer, however, dispose of it as oversized garbage.



Oversized Garbage

Twice a month

Fee-based

Used metal products (30cm or more), furniture (50cm or more), etc. from households

- Apply for collection **three days (excluding Saturdays and Sundays) before** the desired collection day.

※If there are too many applicants for the same collection day, collection may be scheduled on the next collection day.

※The city does not collect waste from business activities.

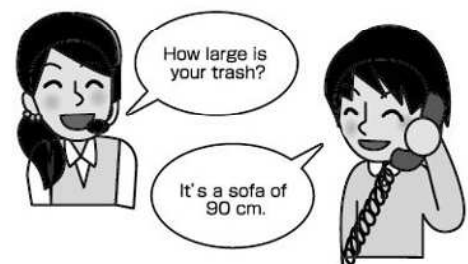

2 Purchase a "Ticket for Oversized Garbage Disposal".

Purchase a "Ticket for Oversized Garbage Disposal" issued by Kawasaki City at a convenience store or a post office (Japan Post Bank) within the city.

*Beginning on December 1, 2023, it became possible to make online payments for bookings made through the Internet.



3 Dispose of oversized Garbage.

Write your name or reception number, and the collection day, on the "Ticket for Oversized Garbage Disposal" (for online payment, any form with the required information (reception number, collection date, amount) written on it) and attach it to your oversized garbage in an easily visible location. Take the trash to the location designated at the time of application by 8:00 a.m. on the collection day.

Oversized Garbage

Fee-based

- Be sure to confirm the oversized Garbage disposal fee amount at the time of application.
- Even if an item is listed, the disposal fee may vary depending on the size and material.
- If you don't speak Japanese, please contact us through someone who does.

	Category	Disposal Fee (per item)	Examples (in Japanese syllabary order)
1	Entirely or partially metal items measuring between 30 and 49cm	¥300	"Itto-kan" cans (18-liter square cans) not for food use, gas cassette stove, ventilator, juicer/mixer, lighting equipment, rice cooker, tuner, video deck, record/CD player (CD/DVD), pots, radio/cassette player, etc.
2	Items between 50 and 179cm	¥600	Knitting machine, amplifier, garment box, chair, unicycle, gas table, carpet, shelving unit, stand, mirror-dressing table, shoe stand, "kotatsu" heated table, "kotatsu" board, golf club, stove, lumber, legless chair, low table, cupboard, shopping cart, bicycle, ski carrier, ski pole, shovel, suitcase, heater, snowboard, speaker, electric fan, sofa, dresser-drawer, child seat, tea ceremony box, desk, table, TV stand, tin plate, pipe, hanger rack, futon, printer plywood, baby carriage, bookshelf, mattress, hot water pot, etc.
3	Items 80 cm or longer with a width of less than 10cm	¥600	Curtain rail, lumber, fishing pole, clothes-drying pole, pipe, etc.
4	Items 80 cm or longer (excluding items in Category 3 above)	¥1,200	Storage shelf, "shoji" screen, bookshelf, sofa, dresser-drawer, door, "fusuma" sliding door, bed frame, spring mattress, etc.

The length of the oversized Garbage is the longest side considering the length, width, height and diameter (for circular items)



※ The disposal fee may vary if you are able to disassemble or fold your oversized trash. Please confirm this when making your application.

Handling of Bundles/Sets - The following Oversized Trash are handled by the bundles (5 per bundle) or by the set.

	Type	Examples
Bundle (5 items per bundle)	Furniture	"Zaisu" chair (legless chair) (except for revolving one), blind, roll curtain, curtain rail, etc.
	Bedding	Futon, Mattress (excluding those with springs), etc.
	Fittings	"Fusuma" (sliding door), "tatami" (Japanese mat), tin plate, etc.
	Sport, hobby	Golf club, ski, ski pole, fishing pole, etc.
	Others	Garment box, shovel, pipe, plywood, mop, etc.
Set	Bedding	Bed frame and mattress (including springs)
	Sport, hobby	Golf bag and golf club, ski set (ski, pole, shoes), etc.
	Appliances, audio equipment, office equipment, musical instrument	"Kotatsu" (leg warmer) and kotatsu table, stereo set (amplifier, player, tuner, speaker, etc.), etc.
	Furniture	Learning desk and chair, dresser and chair
	Health appliances	Dumbbell, barbell (bar and weight)
	Others	Clothes-drying poles and pedestal

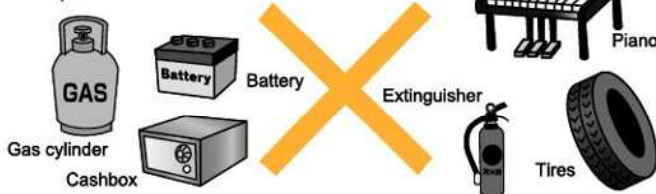

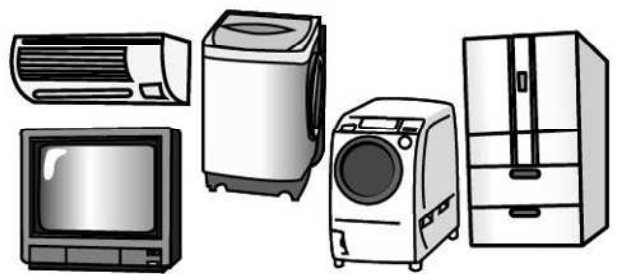

Starting April 1, 2022, the removal of recyclable waste from waste stations and community recycling stations is prohibited by ordinance.

[Overview]

- Prohibition of the removal of waste items subject to administrative collection (such as empty cans and oversized waste) from waste stations
- Prohibition of the removal of waste items subject to community recycling (such as used paper and cardboard) from community recycling stations
- [If you witness someone removing prohibited waste items]**
- To avoid problems, do not contact the person who is removing the prohibited waste items. Please contact the Living Environment Service Office.
- Please provide the location, number, and characteristics of the persons, the brand of vehicle used, and other information as you can.
- <Notes>**
- The prohibition of removal does not apply to items that are directly donated by the waste station manager.
- The prohibition of removal may not apply to the sorting and relocation of waste conducted for the cleaning of stations by users.
- The carrying of recyclable waste is not considered removal.

- Se prohíbe llevarse del Lugar de Recolección Comunitaria de Recursos Naturales los objetos reciclables para la recolección comunitaria de recursos naturales (papeles usados, cartones, etc.).
- [Al encontrar a alguien que se lleve los objetos reciclables]**
- Al encontrar a un individuo que se lleve los objetos reciclables, póngase en contacto con la Oficina de Ambiente de Vida. No hable directamente con el individuo para evitar que usted tenga algún problema.
- Favor de informarnos en la medida de lo posible los detalles como lugar o dirección del hecho, número de personas del acto en cuestión y sus rasgos distintivos, la marca de automóvil, etc.
- <Observaciones>**
- Cuando reciben los recursos reciclables directamente de la persona que gestiona el depósito de basura o recursos reciclables, no corresponde a los actos prohibidos.
- Es posible que no correspondan a los actos prohibidos aquellos actos como orden y limpieza, desplazamiento, etc., lo que realizan como actividades de limpieza por los usuarios del depósito de basura o recursos reciclables.
- Aquellos actos que simplemente transportan los recursos reciclables, etc. no son sujetos a los actos prohibidos como llevarse los objetos reciclables.

A partir do 1º de abril de 2022 será proibido por decreto, levar sem permissão os materiais de reciclo, etc., a partir do local de coleta de lixo ou do local de coleta em grupo de recursos.

- No caso de ver alguém que está levando algum material sem permissão, evite chamar a atenção diretamente, pois existe a possibilidade de criar problemas, por isso, pedimos por favor para que avise ao Escritório do Ambiente da Vida.
- Por favor, informe-nos sobre o que sabe: o endereço do local, o número de pessoas que estavam realizando a ação e suas características, o modelo do carro que estava sendo usado etc.

- No caso ter recebido o material diretamente a partir da pessoa que administra o local de coleta, não será adequado a ação de levar sem permissão.
- Há casos da ordenação, deslocamento etc., realizadas como atividades de limpeza pelas pessoas que utilizam o local de coleta de lixo, não serem adequadas como ação de levar sem permissão.
- A ação de somente transportar os materiais de reciclo não é considerado como ação de levar sem permissão.

- Nghiêm cấm lấy đi các danh mục sản phẩm thu gom của các tổ chức tài nguyên (giấy cũ, thùng carton, v.v...) từ các địa điểm tập kết thu gom của các tổ chức tài nguyên
- [Trường hợp phát hiện lấy đi]**
- Trường hợp phát hiện người có hành vi lấy đi, có khả năng sẽ xảy ra rắc rối nên đứng lên tiếng trực tiếp mà vui lòng liên hệ với Văn phòng Môi trường Sinh hoạt.
