Questionnaire request for those who filed pregnancy notification

This questionnaire is being sent to women around 6 to 7 months
pregnant based on information from their pregnancy notification.

<If you are no longer pregnant> There is a notice regarding your maternity support benefit, so please read it.

Kawasaki City provides continuous close-following consultation support for households from pregnancy to childbirth and child-raising period. This includes consultations at the time of pregnancy notification, consultations during visits to all households of infants following birth, and consultations up to 8 months of pregnancy so that residents can give birth and raise their children with peace of mind.

This questionnaire asks about your current situation and provides information on services related to pregnancy, childbirth, and child-rearing and provides information on consultations for those who would like to use such services. Please make sure to respond to the questionnaire.

Also, based on the responses, we will contact those who are seeking advice or who are deemed to require follow-ups. They are interviewed by staff from each ward office, branch office, or contracted service provider (Kawasaki Nursing Association). You will be provided with additional details about an interview by telephone.

■ About application for maternity support benefit

The maternity support benefit can be paid to registered residents of Kawasaki City who have filed the pregnancy notification.

As the first payment of the maternity support benefit, you will receive the payment of “50,000 yen per pregnancy”. If you have not applied yet, please apply as soon as possible from the application guide given to you during your pregnancy notification (*1).

As the second payment of the maternity support benefit, you will receive the payment of “50,000 yen per unborn child”. Please apply using the application guide given to you following the visit to all households of infants following birth (*2).

* 1 You can apply within a 2-year period from the date on which you confirmed that you are pregnant. In the future, we do not plan to send out application recommendation notices individually. Therefore, we recommend that you apply as soon as possible. If you do not have an application guide, please contact the call center on the back. If you have already applied, please note that it may take up to 3 months for the money to be deposited. Please note that you are not eligible to receive the benefit if you have already submitted an application and received the benefit in another municipality.

* 2 You can apply within a 2-year period from the date that is 8 weeks before your pregnancy due date. Even if you are no longer pregnant due to factors such as a miscarriage or stillbirth, you are still eligible to receive the gift.

■ If you are no longer pregnant

You are still eligible to receive the maternity support benefit even if you are no longer pregnant. The application guide will be sent to the address you enter when responding to this questionnaire. Therefore, we ask that you respond to the questionnaire. (There are no questions about your current pregnancy or childbirth status.)

Kawasaki City has also created a website with details of support groups and other information with the aim of alleviating some of the pain or hardship you may be experiencing. Please visit the website as needed.
