Supporting those who have financial difficulties as their children enter municipal elementary and middle schools!

Q1 : What exactly is school aid?

Q2 : Who is eligible to receive school aid?

A1 : It supports you with the necessary funds for attending municipal elementary and middle schools

(Example)



*In principle, school collections must be paid.

A2 : Those who fall under the following application reasons can apply for school aid.

Please feel free to apply if you wish to receive school aid but are not sure if these reasons apply to you.

Application Reasons	
(1)	Receiving money for livelihood protection
(2)	If livelihood protection was suspended or discontinued this year or last year
(3)	Receiving Child Support Allowance *Those receiving Child Allowance or Special Child Support Allowance are not eligible
(4)	Below the salary base amount for 2024 (see approximate amount)
(5)	Other economic difficulties

*For (5), please check the separate paper "Reasons why assistance is recognized as necessary even though the authorized base amount is exceeded, and necessary documents."

*1 Applicants can choose to apply online or through a paper form. All applications are to be sent to the Kawasaki City Board of Education, Academic Affairs Section.

*2 Those approved as of March 31, 2025, do not need to submit an application form. (You will be screened as someone who has already applied).

*3 You can apply throughout the year, but if you are approved, in principle aid costs will be provided from the month of application or later. To be approved at the beginning of the fiscal year (April 1) you must apply by June 2.

*4 The first results notice will be sent at the end of July. If you miss the first screening due to the application period of application content, then the results will be sent as soon as possible from August or later in accordance with the provision period.

*5 The 2nd provision is sent only to those who did not receive the 1st provision or those who have provisions for school trip fees.
