
Request to Submit Application for School Aid



Everyone should submit application form for school aid

- Regardless if you apply or not, households that receive this notice should submit either form. Only those attending private schools or special support schools are not required to submit.
- If the submission deadline set by the school passes, there may be delays in receiving school aid or you may not be able to receive it.

- Even after the deadline for submitting the application form to schools, applications are accepted until March 2025. However, if authorized, in principle you are eligible for support the month after your application.
- *2 Notices of authorized results are sent to those who apply midway through the year and those who submit additional documents, and are sometimes sent in accordance with the provision period even from August.
- *3 The 2nd provision is sent only to those who did not receive the 1st provision or those who have provisions for school trip fees.

Those who have been approved for school aid as of the end of 2024 do not need to submit the application form when applying for school aid in 2025.
